THESE WARRANTIES DO NOT COVER: (1) workmanship of installation; (2) dissatisfaction, problems or damage due to installations or maintenance other than as specifically recommended by W.F. Taylor Co., Inc. (recommended installations are available through an authorized W.F. Taylor distributor or by writing W.F. Taylor Co., Inc. Technical Services Department, 11545 Pacific Avenue, Fontana, CA 92337; (3) the stability of the product installed or its suitability for installation; (4) condition of the sub-floor, including but not limited to excessive moisture, alkalinity or hydrostatic pressure.

## NOTICE OF CLAIMS

All claims involving unopened or unusable product should be made with your local W.f. Taylor representative or with the Customer Service Center. Notification of claims for products involved in completed installations shall be in writing and sent to W.F. Taylor Co., Inc., Technical Service Department, 11545 Pacific Avenue, Fontana, CA 92337. W.F. Taylor Co., Inc. will designate a carrier and assign a return authorization number for all materials authorized for return. No return of merchandise will be accepted without prior authorization. All claims not made in writing and received By W.F. Taylor Co., Inc. within one (1) year of purchase shall be deemed waived. ANY CLAIMS MADE WITHIN THE WARRANTY PERIOD ARE SUBJECT TO INSPECTION BY AN AUTHORIZED W.F. TAYLOR REPRESENTATIVE, NO CLAIMS WILL BE ACCEPTED FOR INSTALLATIONS THAT HAVE BEEN REPAID OR REPLACED PRIOR TO INSPECTION BY A W.F. TAYLOR REPRESENTATIVE.

THE BUYER'S SOLE AND EXCLUSIVE REMEDY AGAINST W.F. TAYLOR CO., INC. FOR ALL CLAIMS ARISING HEREUNDER FOR ANY AND ALL DAMAGES RESULTING FROM ANY CAUSE SHALL BE THE RECEIPT OF AN EQUAL AMOUNT OF MATERIAL TO REPLACE THE DEFECTIVE MATERIAL, OR AT THE OPTION OF W.F. TAYLOR CO., INC. THE REFUND OF THE PURCHASE PRICE FOR SUCH DEFECTIVE MATERIAL. IN NO EVENT, INCLUDING THE CASE CLAIM OF NEGLIGENCE SHALL W.F. TAYLOR CO., INC.
